6 DAY STANDSTILL:-If cattle, sheep, goats or pigs are moved onto a holding then **no** cattle, sheep, goats or pigs can be moved off the holding within six clear days of that movement (or 20 days for pigs). The standstill starts when the animals are brought onto the holding, and the six day count starts on the following day.
